ASSUMPTION OF RISK RELEASE OF LIABILITY  
WAIVER OF RIGHTS AND INDEMNITY AGREEMENT

In consideration of being permitted to hunt with Northern Plains Outfitters, Inc. and to participate in related activities (hereinafter collectively referred to as the "Activities"):

I, \_\_\_\_\_, the undersigned Hunter, acknowledge and understand that Hunting is a very dangerous activity that involves inherent known and unanticipated risks that may result in serious injury, death, or property damage. I agree to assume full responsibility for all risks of loss, damage, and injury or death that I may sustain while engaging in the activities.

I hereby for myself, my heirs, administrators, personal representatives, assigns, and estates, forever RELEASE AND DISCHARGE Northern Plains Outfitters, Inc., Northern Plains Properties, LLC, Sparling Farms, Elk Pass Properties, Jeff Odaniel, John Odaniel, Mike Odaniel, Charles Sparling, Gordon Helms Ranch or any other Rented or Leased Lands, its owners, employees, agents, and their insurers (hereinafter collectively referred to as the "Release Parties") from any and all losses, liabilities, claims, demands, causes of action and costs (including attorney's fees) that I may hereafter have for death, injuries, and property damage arising out of or related to my participation in the Activities, whether caused by the negligence of the Release Parties or otherwise.

I further agree that I WILL NOT SUE OR MAKE CLAIM AND WAIVE THE RIGHT TO DO SO against the Released Parties for losses, liabilities, damages and costs (including attorney's fees) arising out of or related to my participation in the Activities, whether caused by the negligence of the Released Parties or otherwise. I hereby instruct my heirs, administrators, personal representatives, assigns, and estate never to institute and sue or action at law or otherwise against the Related Parties, nor to initiate or assist the prosecution or any claim or cause of action that I, my heirs, administrators, personal representatives, assigns, and estate may have by reason of my death, injuries or property damage arising out of or related to the Activities, whether caused by the negligence of the Release Parties or otherwise.

I further agree to INDEMNIFY AND HOLD THE RELEASE PARTIES HARMLESS from any and all losses, liabilities, claims, judgments, and costs (including attorney's fees) incurred in connection with any action brought as a result of my participation in the Activities, whether caused by the negligence of the Release Parties or otherwise.

I further agree to INDEMNIFY AND HOLD THE RELEASED PARTIES HARMLESS from any and all losses, liabilities, claims, demands, judgments, and cost's (including attorney's fees) for death, injury or property damage I may negligently or intentionally cause while participating in the Activities of hunting with Northern Plains Outfitters, Inc. and the other's mentioned above or any rented or leased lands.

I understand that injuries received may be compounded or increased by negligent rescue operations or procedures of the Released Parties. I further agree that this Agreement extends to all acts of negligence by the Release Parties, including negligent rescue operations and procedures.

I understand that this Agreement is intended to the final, complete, and exclusive statement of the terms hereof notwithstanding any representations, statements, or agreements to the contrary heretofore made. I further recognize and agree that any modification of the Agreement shall be binding only if evidenced in a writing signed by Northern Plains Outfitters, Inc.

This agreement is made in the State of South Dakota, County of Spink, and shall be in all respects governed in accordance with the laws of the State of South Dakota. I further agree that this Agreement is intended to be as broad and inclusive as permitted by the laws of South Dakota and if any portion thereof is held invalid, I agree the balance shall, notwithstanding, continue in full legal force and effect.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY OF MY OWN FREE WILL WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO ME. I INTEND MY SIGNATURE TO BE COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
